The deputation will be treated as public interest. A certificate to the effect that no disciplinary / vigilance case is pending / being contemplated against the candidate may also be furnished while forwarding the application.

Incomplete applications or those received after the prescribed due date or without APAR's/vigilance clearance certificate will not be entertained.

While submitting the application of willing candidates, he/she may be kept in mind the ICAR guidelines/instructions vide F. No. 33-8/2016-Estt.I dated 19.09.2016 that the part of service rendered by the transferred employee prior to his transfer after availing the last promotion in the parent Institute shall not be counted for the purpose of his/her promotion to the next higher grade in the new Institute/Headquarters. For availing promotion including by Limited Departmental Competitive Examination (LDCE) to the next higher grade he/she has to render the prescribed years of service, as per Recruitment Rules in the new Institute/ Headquarters. He/she has to start afresh his service in the new Institute/ Headquarters being placed at the bottom of the concerned cadre, however, his existing pay may be protected.
